OTP Bank Plc. announces that – according to the single permission from the Hungarian National Bank for the repurchase of Common Equity Tier 1 (CET1) instruments – on 10 June 2024 the Bank purchased 25,213 own shares at an average price of HUF 17,598 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 2,089,543 shares. The stock of own shares is 0.75%.
