Scope Ratings affirms AutoWallis credit rating

Budapest, July 2, 2025 – Scope Ratings has completed the annual review of AutoWallis Plc's credit rating, leading the independent institute to affirm the stable outlook of the Hungarian stock exchange-registered automotive company and its debt. For the current rating, Scope used the rating issued last year, which had already taken into account AutoWallis' business plans, including its updated growth strategy and financing plan, and it also examined the company's results for all of 2024 and the first quarter of 2025.

Scope Ratings GmbH has once again this year reviewed the rating first assigned to AutoWallis Plc, listed on the Prime Market of the Budapest Stock Exchange, in 2019, leaving the rating unchanged (B+). In the rating process, the independent institute considered AutoWallis' regional expansion and the diversification of the brands it represents as positive factors, among others, and identified as a challenge the fact that it remains a minor entity within the European retail industry. Scope Ratings also left the rating of the company and its debt unchanged: the B+ rating was upheld for both, with a stable outlook.
