

EXTRAORDINARY INFORMATION

on the purchase of own shares within the framework of the share buyback program of CIG Pannónia Life Insurance Plc.

CIG Pannonia Life Insurance Private Limited Company (registered office: H-1097 Budapest, Könyves Kálmán körút 11.B, company registration nr.: 01 10 045857, hereinafter referred to as **Company**) hereby informs its Esteemed Shareholders and the other participants of the capital market that within the framework of the share buyback program¹ published on June 3, 2026, in order to provide benefits to the MRP organization and in order to operate the management interest system, MBH Bank Plc., as an investment service provider, purchased 884 own shares on the stock exchange on August 6, 2026 at an average price of HUF 304.

As a result of the transaction, the Company's own shares increased from 62,371 to 63,255 shares, which is 0,067 % of the total number of the issued shares.
