



Extraordinary Announcement of 4iG Plc.

on the Austrian competition clearance for CSG DEFENCE's indirect acquisition in RÁBA Nyrt. and direct acquisition in Hirtenberger Defence Systems Kft.

4iG Public Limited Company ("4iG") hereby informs the participants of the capital market that the Austrian Federal Competition Authority has granted its approval for the acquisition by CSG DEFENCE a.s. ("CSG DEFENCE") of a 49% shareholding in 4iG SDT EGY Zrt., as a result of which CSG DEFENCE would indirectly acquire a 36.75% interest in RÁBA Járműipari Holding Nyilvánosan Működő Részvénytársaság ("RÁBA") ("RÁBA Transaction").

The mandatory public takeover bid approved by the National Bank of Hungary by its resolution No. H-KE-III-218/2026 and published on 19 March 2026 (the "Public Takeover Bid") was accepted in respect of a total of 32,970 ordinary shares of RÁBA during the acceptance period. Given that **all competition authority approvals required in connection with the RÁBA Transaction have been obtained**, pursuant to Section 1.3.6.3 of the Public Takeover Bid, **the share sale and purchase agreements between 4iG SDT EGY Zrt., as the offeror, and the shareholders who accepted the Public Takeover Bid were concluded as of today**. In accordance with the terms of the Public Takeover Bid, **4iG SDT EGY Zrt. will arrange for the payment of the consideration for the shares to the relevant shareholders within five business days**.

At the same time, the Austrian Federal Competition Authority also approved the direct acquisition by CSG DEFENCE of a 49% shareholding in Hirtenberger Defence Systems Kft. ("Hirtenberger Transaction").

Closing of the RÁBA Transaction and the Hirtenberger Transaction is expected to take place in the near future, following the satisfaction of the other applicable conditions precedent.
