



Extraordinary Announcement of 4iG Plc.
transaction of subsidiary

4iG Nyilvánosan Működő Részvénytársaság (**"4iG"**) hereby informs the participants of the capital markets that on 2 March 2026, 4iG Űr és Védelmi Technológiák Zártkörűen Működő Részvénytársaság (registered seat: 1013 Budapest, Krisztina körút 39.; company registration number: Cg. 01-10-142725), a subsidiary of 4iG, as seller (**"Seller"** or **"4iG Űr és Védelmi Zrt."**), entered into a share purchase agreement with CSG DEFENCE a.s. (registered seat: U Rustonky 714/1, Karlín, 186 00 Prague 8, Czech Republic; company registration number: 073 33 528; registered with the Municipal Court in Prague; **"CSG DEFENCE"**), as purchaser, for the sale and purchase of 980 ordinary shares, each with a nominal value of HUF 5,000, representing 49% of the registered capital of 4iG SDT EGY Zártkörűen Működő Részvénytársaság (registered seat: 1013 Budapest, Krisztina körút 39.; company registration number: Cg. 01-10-143379), wholly owned by the Seller (the **"Transaction"**).

Following the satisfaction of all conditions precedent, the Transaction was closed on 2 September 2026. As a result of the Transaction, CSG DEFENCE acquired a 36.55% indirect interest and 36.88% indirect controlling interest in RÁBA Járműipari Holding Nyilvánosan Működő Részvénytársaság (registered seat: 9027 Győr, Martin út 1.; company registration number: Cg. 08-10-001532; **"Target Company"**), while, simultaneously, 4iG Űr és Védelmi Zrt.'s indirect ownership interest in the Target Company decreased to 38.04%, and its indirect controlling interest decreased to 38.38%. The free float in the Target Company amounts to 25.42%.
