

EXTRAORDINARY INFORMATION

on the purchase of own shares within the framework of the share buyback program of CIG Life Insurance Plc.

CIG Life Insurance Private Limited Company (registered office: H-1097 Budapest, Könyves Kálmán körút 11.B, company registration nr.: 01 10 045857, hereinafter referred to as **Company**) hereby informs its Esteemed Shareholders and the other participants of the capital market that within the framework of the share buyback program¹ published on June 3, 2026, in order to provide benefits to the MRP organization and in order to operate the management interest system, MBH Bank Plc., as an investment service provider, purchased 961 own shares on the stock exchange on September 24, 2026 at an average price of HUF 307,57.

As a result of the transaction, the Company's own shares increased from 93,453 to 94,414 shares, which is 0,1 % of the total number of the issued shares.
