submission of an application for approval by the Albanian, Montenegrin and North Macedonian competition authorities for the acquisition of direct sole control over Rába Nyrt., and the merger involving the acquisition of direct and indirect ownership interests in Rába Nyrt., N7 Defence Zrt. Hirtenberger Defence Systems Kft. and VAB Kft. as being of national strategic importance

4iG Public Limited Company ("4iG") hereby informs the participants of the capital market that 4iG's subsidiary, 4iG SDT EGY Zártkörűen Működő Részvénytársaság (registered office: 1013 Budapest, Krisztina körút 39., company registration number: 01-10-143379, tax number: 32873829-2-41) has acquired direct sole control over Rába Járműipari Holding Nyrt. (registered office: 9027 Győr, Martin út 1., company registration number: 08-10-001532, tax number: 11120133-2-51) for the purpose of approving the merger based on the acquisition of direct sole control ("Transaction 1") the relevant competition authority applications have been submitted to the Albanian Competition Authority, the Montenegrin Competition Protection Agency, and the North Macedonian Competition Authority.

The Government, with the decree number 303/2025. (X. 6.) ("Government Decree") classified the merger as being of national strategic importance in the public interest, taking into account defense industry supply security considerations, pursuant to Section 24/A of Act LVII of 1996 on the Prohibition of Unfair Market Practices and Restriction of Competition:

a) Transaction 1;

b) acquisition of direct and indirect ownership interests by 4iG Space and Defense Technologies Private Limited Company (registered office: 1013 Budapest, Krisztina körút 39.; company registration number: 01-10-142725; tax number: 32500640-2-41) in N7 Defence Holding Zártkörűen Működő Részvénytársaság (registered office: 1087 Budapest, Asztalos Sándor út 2.; company registration number: 01-10-143317; tax number: 32842230-2-42), and Hirtenberger Defence Systems Védelmi Ipari Korlátolt Felelősségű Társaság (registered office: 8100 Várpalota, Szent István út 16. 3. em. 313. ajtó; company registration number: 19-09-524041; tax number: 27028308-2-51) ("Transaction 2");

c) acquisition of direct and indirect ownership interests by 4iG Space and Defense Technologies Private Limited Company (registered office: 1013 Budapest, Krisztina körút 39.; company registration number: 01-10-142725; tax number: 32500640-2-41) in VAB Korlátolt Felelősségű Társaság (registered office: 1087 Budapest, Asztalos S. út 2.; company registration number: 01-09-409891; tax number: 32164822-2-51) ("Transaction 3").
